Feedback from the Waitangi Weekend event in Waitara:

The weekend event hosted by the Friends of the Waitara River Group was very successful with many locals attending and fun camping overnight at the Marine (Outfall) Park. Highlights were the historic walk with Ray Watembach looking at the sites of maori pa destroyed in the 1860s to secure land for settlers and the changes then made to the river which reduced river transport from 100km inland to just 7km now. The speakers forum and discussion on Sunday was very informing covering the state of the river from industry and sewage pollution; to terraquaculture that can massively increase food production sustainably through land-use diversification; to really scary global warming sea changes and hopeful international activism for

indigenous rights. It is hoped to hold the event again next year.

Feedback from the Coal Action Network Summer

"The Festival was the biggest event we've organised so far... [resulting in] a big upsurge in local and regional group activities, much of it sparked off by the Festival.

"About 150 people registered to attend, many of whom were there throughout the Festival, and in addition, up to 100 further local people joined festival-goers for our Community Day at the Mataura Community Centre, where we heard from a range of speakers on the effects of large-scale coal and lignite mining on the climate, on health, and on rural communities."

"Just how difficult it must be for [Mataura farmer] Mike to hold out is made plain when you see a map of the Mataura valley with his land surrounded by what, if Solid Energy have their way, will become a very, very large opencast lignite mine.

"Of course, Mike isn't the only beleaguered farmer, either in New Zealand or overseas. Queensland farmer, Sid Plant, got a standing ovation from a packed audience in the Mataura Community Centre when he described how his family had stood up to the mining company, New Hope, despite suffering enormous stress as neighbour after neighbour was bought up by the company.

"The mining companies all say 'we will make it better than it was' but they destroy the land – it can never be rehabilitated. I've witnessed the desecration of the best quality farmland where I live – just as Solid Energy is about to do in Southland. You can never get it back," Mr Plant told the meeting.
