MEDIA RELEASE: Climate Justice Taranaki contradicts Todd

'In a recent submission to the Parliamentary Commissioner for the Environment (PCE), Climate Justice Taranaki (CJT) has highlighted the complex issues surrounding hydraulic fracturing (fracking) operations in New Zealand and their far reaching impacts, should they be allowed to proliferate.

"Instead of providing greater transparency in response to public concerns, the industry has continued to 'spin', tell the public half-truths, claim media space, insist on confidentiality agreements with landowners, and buy their so-called 'social license' with donations and sponsorships for schools, community groups and public events," said CJT researcher Catherine Cheung.'

MARINE BIOTOXIN EVENT - Taranaki - PUBLIC HEALTH WARNING!

Tuesday, 6 November 2012 16:29

Today, the Taranaki Public Health Unit (PHU) was notified by the Ministry of Primary Industry that the Mohakatino monitoring site, north of Taranaki, had exceeded the Maximum Acceptable Value for PSPs in shellfish.

The current warning covers the area from Mohakatino to Motunui. This warning is an extension to the area Kawhia/Raglan - Mokau where a public health warning had been released by the Waikato District Health Board.

A media release has been drafted by the Taranaki PHU. The PHU will also be erecting warning signs at all known public access points along the coast including boat ramps, camp grounds, fishing sites etc. The Taranaki PHU will continue to monitor the situation and will keep you updated. Economic folly

It is interesting that the arguments around mining and drilling are always phrased as a pure economics vs environmental issue, as if the environment is like a british garden, purely for the enjoyment of the priviledged.

We need to understand the issue more clearly as a longterm economic and social issue and the environment as everything around us that sustains our lives and the lives of all those around us and yet to come. A healthy environment = a healthy economy.

These companies who want to come into our territories to take resources and flog them off for large profits for themselves and their well-off shareholders are only looking at short term economic gain for a few. The longterm cost is massive and often indirect and conveniently hard to prove, but that cost is borne by all (eg. climate chaos, environmental destruction) and most heavily on those who are the least well off and the least to blame.

A 20 year mining industry might bring in taxes for the politicians to spend as they wish and a few jobs for a few years for a few people. Contrast that with the fishing economy that it could temporarily or even permanently destroy which can provide food and employment for many more people, local people, and potentially last forever if we manage our takes sustainably.

The same can be said with our current industrial farming methods which mine our once rich soils. We could feed our soils organic nutrients instead of bombarding them with petrochemicals and heavy machinery and have a thriving rural economy again instead of this near feudal system which drives our young to the cities.

If we get out of this short term mindset and into a longterm one we will see clearly and make the right decisions for all generations to come.
