

The reasons for making my submission are¹: (further information can be appended to your submission, see footnote).
Climate Justice Taranaki is strongly against the use of any neonicotinoid pesticides because of the following reasons:
- Neonicotinoid pesticides including thiamethoxam harm bees, and have been linked to mass mortality and sublethal effects in bees (1, 2);
- Many countries including France, Germany and the European Union have a ban or severe restrictions on the use of neonicotinoid pesticides due to the undeniable harm on bees (1, 3, 5, 7);
- Neonicotinoid pesticides are persistent in the environment and their residues have been found in many fruits and vegetables, with potential food safety and long-term human health effects (4);
- The effects of persistent neonicotinoid pesticides on New Zealand's threatened species and the cascading effects on our ecosystems are largely unknown (6);
- Any further threats on NZ's bee populations, native species, natural ecosystems, food safety and marketing image will adversely impact on the economic viability of our agricultural, horticultural, apicultural and tourism industries.
